As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.
 - Penetration time of glove material
The exact break through time has to be found out by the manufacturer of the protective gloves and has to be observed.
 - For the permanent contact of a maximum of 15 minutes gloves made of the following materials are suitable:
Butyl rubber, BR
Nitrile rubber, NBR
